### **Instructions**

#### **Applicant**

---

To apply to be a precinct committee officer of the Snohomish County Democratic Central Committee (SCDCC), you must do the following:

- Declare that you are a Democrat.
- Complete this application.
- Approach the Democratic legislative district organization where you live to endorse this application.

#### **Legislative District Organization**

---

The legislative district organization does the following:

- Establish rules and procedures to endorse precinct committee officer applications.
- Endorse this application if the legislative district organization approves your appointment.
- Completes the legislative district organization portion of this application.
- Forwards an endorsed application to the corresponding secretary of the SCDCC.

#### **Corresponding Secretary**

---

The corresponding secretary of the SCDCC collects and presents endorsed precinct committee officer applications to the Executive Board of the Snohomish County Democratic Central Committee for its consideration.

After appointment by the SCDCC chair, the corresponding secretary keeps the official list of precinct committee officers.

#### **Executive Board**

---

The Executive Board of the SCDCC makes a recommendation to the chair of the SCDCC regarding this application.

#### **Chair**

---

The chair of the SCDCC may appoint you to be a precinct committee officer if this application has been endorsed by your legislative district organization and received a favorable recommendation by the Executive Board.
